INSTALLATION:

To install, manually copy (using cp from the UNIX command line) the executables (EcPIPREditor_IF, EcPISubMgr, and EcDpPrDeletion) over your existing files, making sure to maintain correct ownership and permissions.

If the database patch for Iris.03 was previously installed, it is unnecessary to install the database patch provided in Iris.04; they are identical. To install the PLS database patch, execute the database patch from EcCoAssist, following normal installation procedures for the PLS database (see the 5A.04.Diablo installation instructions for PLS for reference). At the completion of the patch, the Versionid of the PLS database should be 5009.

Iris.04 replaces and makes obsolete the Iris.03 test executables.
